**Audit Report for the year ended 31 March 2006**

**Matters to be reported**

**Previous audit reports**

The parish council has not taken appropriate action on all matters raised in previous reports from the internal and external auditors. It was reported in the audit report for the year ended 31 March 2005 that the level of fidelity guarantee insurance was low. The council have not raised the insurance during the year ended 31 March 2006. However, we note that the council commenced a review of all aspects of its insurance policy during the year ended 31 March 2007.

**Other matters not affecting our opinion which we wish to draw to the attention of Swindon Parish Council**

**Fidelity guarantee insurance**

As reported in the audit report for the year ended 31 March 2005 the fidelity guarantee insurance currently held by the council is inadequate. The council should consider raising the level to at least the total of the balances held plus one half of the precept.

**Late approval of accounts**

The Accounts and Audit Regulations 2003 require that local councils approve the accounts by 30<sup>th</sup> September immediately following the year end.

Swindon Parish Council has not complied with this requirement for the year ended 31 March 2006.
