# 19/129 MINUTES OF PREVIOUS MEETING

The Council **RESOLVED** to accept the minutes of 18<sup>th</sup> June 2019 as a true record.

#### 19/130 MATTERS ARISING

ACTION 18/178/1 – The Clerk to raise cycle path issues with Cllr. Fisher. Wrote on 4<sup>th</sup> December, response awaited. The Clerk will remind Cllr. Fisher. **Action continues**.

ACTION 19/106/1 – The Clerk to approach other local councils to firm up the requirement for evening training places. It was agreed that the Clerk would fix a date with Clrs. Cornish and Pirso before inviting wider participation. **Action continues**.

ACTION 19/121/1 – The Clerk to ask Cllr. Clucas for a report on the proposed CBC motion of support for the agreed area of Local Green Space. **Action continues**.

#### 19/132 COUNCIL'S FINANCIAL POSITION

The Clerk tabled a report of the Council's finances for the first quarter (1<sup>st</sup> April 2019 to 30<sup>th</sup> June 2019) and a bank reconciliation as of 30<sup>th</sup> June 2019.

# 19/133 PLANNING AND LICENSING

19/01178/FUL – Linking of two buildings at Costa Coffee.

**NEW ACTION 19/133/1** – The Clerk to chase the planning officer for her reaction to anomalies that Cllr. Allen had noted in the application.

- 19/01270/COU Change of use from car showroom (disused) to a gym. Not yet reviewed.
- 19/01260/OUT Change of land at corner of Manor Road to a small industrial estate (speculative development). There were concerns about the proposed road accesses to the site.

**NEW ACTION 19/133/2** – Cllr. Allen to summarise and circulate his observations.

There were no licencing applications to consider.

#### 19/134 SUNDIAL MOSAIC

Nothing to report.

#### 19/135 SPEED REDUCTION INITIATIVES

It was now thought that the rubber tubes placed across the roads to monitor the traffic were associated with planning application 19/01260/OUT and nothing to do with our request.

**NEW ACTION 19/135/1** – The Clerk was asked to write to Cllr. Bernard Fisher to complain at the lack of action.

#### 19/136 INCONSIDERATE PARKING OUTSIDE THE SCHOOL

Cllr. Pirso had telephoned and emailed the school with a view to setting up a meeting but had not received a reply. Cllr. Pirso said that she would go into the school personally.

# **19/137 INSURANCE**

Cllr. Wells was able to join the meeting at this point.

The Council had received three quotes via Came & Company (brokers).

Company	Quote
Inspire	£315.03
Hiscox	£837.05
Ecclesiastical	£913.68

In addition, a £50 administration charge would be payable regardless of the quote accepted.

The Council **RESOLVED** to accept the Inspire quote. No change in cover was considered necessary.

The Council further **RESOLVED** to enter into a three year agreement, reducing the price by 5% (to £299.28). With the administration charge the total payable would be £349.28.

# 19/138 NOTICEBOARD

The Clerk had written to Chris Riley of GCC Highways (Rob Vale's immediate superior). Mr. Riley's reply (received on 1<sup>st</sup> July 2019) stated that the Council would receive a date

#### **19/143 REPORTS**

A large bag had been placed outside Cllr. Wells' house as a repository for dog bags. It was now full and it was unclear who (if anyone) intended to dispose of it and its contents.

It was noted that there was a blocked drain in the corner of the Mary Godwin pavilion car park.

It was noted that there was a fallen tree at the edge of Manor Road on the bend prior to Dog Bark Lane. Cllr. Conmee had reported it via Fix My Street but it had been incorrectly referred to the Borough Council (should be the County Council).

It was noted that the use of a number of local bus stops had been temporarily suspended. No reason had been given.
